Privacy policy for the website of the ‘NADEUM’ association (see imprint)

The protection of your data is important to us. We therefore want to take this opportunity to inform you about which personal data we process in our association and for what purpose.

1. your membership in the association

As a member of our association, you conclude a membership contract with us. We process the following personal data about you for the purpose of fulfilling the association's tasks in accordance with our statutes:

In accordance with the statutes of the association.

Your data will be stored at the ‘NADEUM headquarters’ for the duration of your membership with us. In the event of your resignation from the association, your data will be stored for the legally prescribed period (usually 7 years or 10 years due to the requirements of some public funding agencies) in order to fulfil our legal storage obligation.

2. Your participation in our events

As a participant in our association's events, your personal data will be stored to the extent necessary for registration or participation in the events. We would also like to inform you that photographs, sound and/or video recordings may be made during our association's events. These recordings may be used in various media (print, TV, online) and in publications (print, online) of our association.

3. your visit to our website

The association is responsible for the content of the website and is both the media owner and the publisher. When you visit our website, we collect the following information



The date and time you access our website

Your IP address

The name and version of your web browser

And the information that you provide by filling out the contact form or registering for our newsletter.

3.1 This data is processed for the following purposes:

- to provide you with this website,
- to further improve and develop this website, and
- to respond to your requests. When you enter personal data on this website, you consent to us using this data electronically for the stated purpose. This data is stored securely and is not passed on to third parties. The only exception to this is the transfer of data to state authorities if the association is legally obliged to do so. There is no obligation to actually provide the data that we ask you to provide on our website. However, if you do not do so, you will not be able to use all the functions of the website.

4. legal basis for the processing

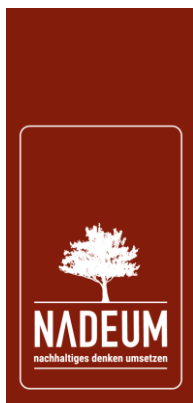
The legal basis for the processing of your personal data is based on your membership relationship, your participation in our events, your visit to our website or is otherwise in our legitimate interest in accordance with the GDPR, which consists of achieving the purposes mentioned under points 1-3 above.

5. cookies This website uses so-called cookies.

A cookie is a file that can be stored on your computer when you visit a website. Cookies are generally used to provide users with additional functions on a website.
